Following discussion and upon motion by Heise supported by Williams; it was

The next order of business was Amendment to the Wayne County Termination Agreement: The Termination Agreement was approved and executed by the Townships and WTUA earlier this summer, and subsequently forwarded to the County for approval and execution. Similar to the two other Agreements, the County has insisted on changes and/or modifications to the Exhibits; namely the maps indicating the swap areas and the WTUA service area. The replacement of these Exhibits also results in some minor modifications to the text of the Agreement itself (but only in reference to the Exhibits). Following discussion and upon motion by Heise supported by Williams; it was

R-19-09-74 Resolved to concur with the recommendation of the Director of Operations to rescind the approval of the prior version of the Termination Agreement; and

Further, to approve the updated version of the Termination Agreement; and

Further, that the Chair sign the Amendment on behalf of the Authority.

The next order of business was Personnel Policies Amendment: In 2012, after the passage of the Affordable Care Act when WTUA switched to a HDHP, the Board approved an increased medical opt-out incentive from \$100 per month to \$150 per paycheck for a total of \$3,900 per year. Our Personnel Policies were not updated to reflect current practice. In addition, the

language for the opt-out specified that the employee, "after verifying to the Authority" that he/she is covered by a medical insurance program through his/her spouse, may elect not to participate in the Authority's medical insurance program. Since it is possible for an employee to be covered under Medicare and not necessarily under a spouse's plan, that language is being updated to remove "through his/her spouse" so that Section 8.1 will now read as follows: An employee, after verifying to the Authority that he/she is covered by another medical insurance program, may elect not to participate in the Authority's medical insurance plan. In this situation the employee, after signing a waiver of insurance form, will be paid a sum of \$150 per pay period to a maximum of \$450 monthly. Lastly, Section 8.2 Dental Insurance is being updated to reflect the current waiting period. Dental coverage previously began on the 1st of the month following 30 days of employment; however, when WTUA switched to BCBS Dental, the waiting period changed and is now the same as medical, which is the first day of the calendar month following the calendar month in which his/her employment as a full time employee commences. Following discussion and upon motion by Heise supported by Williams; it was
