The next order of business was Foster, Swift, Collins & Smith; Legal Rate Increase: During the preparation of the 2016/2017 Fiscal Year Budget, a rate increase was requested by Foster, Swift, Collins & Smith (FSCS). WTUA Currently pays FSCS a rate of \$225.00 per hour for highly experienced/shareholder attorneys; this rate was established and has been in effect since October 1, 2004. FSCS has requested an increase to \$270.00 per hour, which represents an increase of approximately 1.6% per year since 2004. The State Bar of Michigan reported in its 2014 attorney billing pricing rate summary report, a 2013 median shareholder rate of \$310.00. Following discussion and upon motion by Price supported by LaJoy; it was

The next order of business was the Lower Rouge North Pump Station Gas Detection System; Sensor Exchange Program: The Lower Rouge facilities are equipped with a gas detection system that utilizes sensors manufactured by Mine Safety Appliances Company (MSA). These sensors have a very limited lifespan and need to be replaced annually. A number of years ago, we enrolled in a sensor exchange program offered by MSA; this program sends new sensors annually. The primary benefits of the program are that it locks in the cost of the replacement sensors for a period of two (2) years and that price includes a credit for return of the expired sensors. We would like to enroll the North Pump Station Facilities in the same program, as we take over operation and maintenance of those facilities. The two (2) year cost of enrollment is \$5,880. Following discussion and upon motion by Price supported by Nix; it was

R-16-06-40 Resolved to concur with the recommendation of the Director of Operations to enroll in the Mine Safety Appliances Company Sensor X-Change Program for a cost of \$5,880.
